**Contributors shall submit an abstract of not more than 300 words focusing on Important Contemporary Legal Issues. Authors of selected abstracts will be invited to submit the full paper. **Statute Analysis (of statutes enacted in 2018); 2000-3000 words and**

**Book Reviews (of books published in 2018): 900 – 1000 words.**
