The Podcast Committee

1. The first ever episode, dated March 1, 2022, of the RCL Podcast was hosted by Janhavi Nagarhalli and Rakshika Rajesh, (IV th year B.A. LL.B.). They interviewed an eminent **legal career coach Ms Sammanika Rawat: Founder of Your Legal Career Coach**. The Attendance committee

1. As per Karnataka State Law University rules, 75% attendance is mandatory. The monthly attendance consolidated report is displayed on the College notice board before 10th of every month. The principal has repetitively reminded the students via email about the minimum attendance requirement of the University.
2. In case of Medical Exemptions, the minimum attendance criteria is 65%. The verification and collection of medical reports should be done by the respective class teachers at the end of the academic semester. In case of any medical exemption, the students having 75% or above attendance, need not submit the medical exemption letters to the class teachers.
3. If any students have a shortage of attendance in any subject, then they should attend the remedial classes provided by the subject or class teacher for all the batches. The remedial classes will start from 6th September 2022, between 3.00 - 4.00 P.M. every day, including

on Saturdays between 9.00 to 1.00 PM. After 24th September 2022 (last working day), remedial classes will be scheduled between 9.00 A.M. to 1.00 PM.

4. If any student has participated in any activity or committee work then the exemption letters should be submitted, which should state the students' name, class, roll number and section. These exemption letters must be signed by the faculty coordinators or programme coordinator and also by the Principal. If the exemption letters don't have the Principal's signature then it is considered to be invalid. All the exemptions must be circulated to all the subject teachers before the end of each month. The class teachers are requested to ensure that the exemptions are marked in the attendance register by all the visiting faculty members as well.
5. The subject teachers should identify the students who have shortage of attendance or who are not attending the classes regularly and this should be brought to the attention of the class teachers. This is the last month of the semester, therefore, please keep a track on the students and immediately inform to the respective class teachers so that they can inform their parents.

The society had its orientation on 19.08.2022 at 3.00 PM, but owing to an overflow of indoor sports activities held on the same day, only around 61 students attended the orientation. Students across all years and all streams (not alone BBA and B.Com) have shown keen interest to be part of the Society. We were able to identify many students who have their own start-ups. Additionally, students have suggested the need for the enactment of a specific law for entrepreneurs. During the orientation, we have taken requests/feedback from students regarding what sessions/seminars can be conducted through the semester, in order to further the Objectives of the Society.
2. We are in the process of updating the above info on our college website and social media platforms (by today).
3. Since it took us time to get approval to start the Society, we are almost towards the end of the semester, hence we may not be in a position to have many activities. However, we are trying to have at least one or two activities before the semester ends.
